1.0 INTRODUCTION

RENAISSANCE AFRICA ENERGY COMPANY LIMITED is committed to continuous improvement in environmental management through emergency response to oil spills, recovery of the spilled oil and remediation of the spill impacted sites. The objectives of Oil spill response and remediation projects include:

- a. carry out first line emergency spill response to contain and recover spilled oil and thereby mitigate impact to the environment;
- b. clean-up spill impacted area and execute site remediation to reduce the level of contaminants of concern (CoC) in the soil/sediments/groundwater to the level that promotes net environmental benefit;
- c. to ensure that the remediation process meets regulatory requirements for final Certification and
- d. to ensure sustainable oil spill response and remediation practice that meets international best-practice and the oil industry standard.

The oil spill response and remediation scope of work will cut across RENAISSANCE operation areas in East and West Locations.

The proposed contract will commence in Q1, 2026 and remain active for 60 months duration, followed by 24 months extension option based on performance within the primary contract period

2.0 SCOPE OF WORK

The scope of work covers:

1. Provision of Oil Spill Response and Remediation Base, Human Resources, Equipment and Management Systems
2. Emergency Oil Spill Response to Land, Swamp, and offshore locations including:
 - a. Containment of crude oil spill within 24 hours of notification.
 - b. Recovery and evacuation of free phase oil to designated facility
3. Flushing and clean-up of oil spill impacted areas
4. Management of solid and liquid waste on site and those generated from the project activities
5. Soil and Groundwater remediation
6. Reports on Site Activities.
7. Oil Spill Response and Remediation Trainings
8. Training and Provision of Soil and Groundwater Subject Matter Expert

3.0 MANDATORY REQUIREMENTS

1. To be eligible for this tender exercise, interested contractors are required to be pre-qualified as essential service vendor in the Product Groups 3.05.21 (Site Clean-up Services) Product/Services categories in NipeX Joint Qualification System (NJQS) data base.
2. To determine if you are pre-qualified and view the product/service category you are listed for: Open www.vendors.nipex-ng.com and access NJQS with your log in details. Click on Products/Services Status tab to view your status and product.

3. If you are not listed in a product/service category and you are registered with DPR to do business, contact NipeX office at 27B Oyinkan Abayomi Drive, Ikoyi, Lagos with your NUPRC certificate as evidence for verification and necessary update.
4. To initiate the JQS prequalification process, access www.nipex-ng.com, click on services tab followed by NJQS registration.
5. To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

Only successfully pre-qualified suppliers in this category will receive Invitation to Technical Tender (ITT).

4.0 NIGERIAN CONTENT REQUIREMENTS

- Demonstrate that entity is a Nigerian registered company with greater than 51% Nigerian shareholding. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) including company memorandum & article of association and/or evidence of entity's incorporation, shareholding & ownership structure in Nigeria. Tenderer shall provide evidence of NCDMB NOGIC JQS registration.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- Tenderer shall provide Location of in-country facilities (not limited to administrative office, maintenance workshop, fabrication workshop) to execute the work scope.
- Bidder shall provide valid Category 1,2,3, 4 or 5 Non-moveable assets (DA) for Health, Safety and Environment demonstrating ownership of equipment to carry out oil spill remediation and capacity & capability to deploy trained personnel for oil spill remediation.

5.0 CLOSING DATE

Only Tenderers who are registered in the NJQS product/category 3.05.21 (Site Clean-up Services) as at the advert closing date shall be invited to submit Technical and Commercial bids after meeting the prequalification requirements.
