Contractor shall provide diesel supply storage barge. •

Contractor shall provide Crane for loading equipment on the work barges. •

The contractor shall provide security houseboats with catering, housekeeping and laundry services. •

Contractor shall provide means of transportation for personnel and equipment between location site which includes Landing craft, Tugboats, Speed Boats etc.

Provide evidence of at least 50% Nigerian ownership of all equipment to be utilized in the execution of the work scope.
