#### **4.0 NIGERIAN CONTENT REQUIREMENTS**

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also provide the following requirements:

- Demonstrate that entity is a Nigerian registered company with greater than 51% Nigerian shareholding structure. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC 2.3, 2.4, 2.5, etc.) including company memorandum & article of association and/or evidence of entity's incorporation, shareholding & ownership structure in Nigeria.
- Bidders shall provide evidence of 1,2,3, 4 or 5 Service and Support group NCEC demonstrating ownership of equipment (not limited to Piston corer, Jumbo PC, Box corer, scanning sonar etc.) to execute geophysical and geotechnical surveys services.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

Tenderer shall provide Location of in-country facilities (not limited to administrative office) to execute the work scope.


### 5.0 CLOSING DATE
