1.0 INTRODUCTION

Seplat West Limited, the operator of the NEPL/Seplat Joint Venture, hereby invites interested and prequalified companies with proven experience in the provision of drill cuttings and waste management services, including the supply of equipment, personnel, and related support services required for drilling, completion and workover operations in the Western Assets on onshore wells for a contract period of three (3) years, with an option of an additional two (2) years at the Company's discretion.

2.0 SCOPE OF WORK

The scope of work includes the Supply and Provision of Drill Cuttings & Waste Management Services, equipment, personnel and related services. At a minimum, the contractor is expected to supply and provide the following:

- Drill Cuttings and Waste Management Services
- Provision of Empty Skips, Coral Barges (1000MT), Empty Tanker Trucks (33,000 - 45,000ltrs),
- Transportation of Drill Cuttings – Water Base Mud and/or Pseudo-Oil-Base-Mud Cuttings to Contractor's Base (Disposal/Treatment)
- Carry out sampling and collection of samples following NUPRC guidelines
- Perform laboratory analysis and reporting to company on solids/liquids from worksite and for disposable materials in accordance with same NUPRC guideline
- Store the base oil (recovered from waste treatment) prior to being transported (by company) to nominated third party Liquid Mud Plant
- Clean unit for used oil-cuttings contaminated containers (skips) prior to being sent back to worksite.
- Provision of Diesel-Powered KAMA pump, Diaphragm Pump, Tyre-Driven Excavator, 10T Forklift, Competent and Trained field Personnel, Base support from vendors' operational base,
- Other related equipment and personnel

The contract is expected to run for two (3) years with an option to extend for an additional two (2) years, subject to performance and project requirements.

3.0 MANDATORY REQUIREMENTS

- To be eligible for this tender exercise, interested Companies are required to be pre-qualified in Drill Cuttings and Waste Management Services (Cutting Injection / Cutting Disposal) - **Nipex Code 3.04.22** of NipeX Joint Qualification System (NJQS) database. - Any entity intending to bid as a joint venture/alliance must demonstrate a genuine alliance or joint venture with details on scope and responsibilities of parties for this work, and payment arrangements. Such companies must show evidence of joint venture via a legally binding agreement duly signed by the Chief Executive Officer (CEO) of both companies. In the absence of a binding legal agreement relating directly to this activity, the company submitting the response on behalf of the alliance/joint venture must supply a power of attorney authorizing it to do so.
- To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system. In the section below: "OGTAN" shall mean Oil and Gas Trainers Association of Nigeria and "Tenderer" shall mean bidder.

4.0 NIGERIAN CONTENT REQUIREMENTS

Seplat West Limited, as an indigenous Exploration and Production Company in Nigeria, is committed to the development of the capabilities of Nigerian companies in compliance with the provisions of the Nigerian Oil and Gas Industry Content Development (NOGICD) Act 2010 for Nigerian Content Development. Tenderers are to note that they will be requested in the technical tender to provide details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Act, 2010 as provided at <http://www.ncdmb.gov.ng/images/GUIDELINES/NCACT.pdf> in view of the fact that non-compliance will constitute a fatal flaw in all contract evaluations.

In light of the above, Tenderers shall be expected by the Nigerian Content Development Monitoring Board (NCDMB) to:

- Demonstrate that the entity is a Nigerian registered company with greater than 51% equity shareholding. Also, provide form CO2 and CO7, evidence of registration with NCDMB NOGIC JQS and NUPRC certificate.
- Demonstrate detailed description of the location of in-country committed facilities & infrastructure (address, layout drawing, lease document of technical & administrative office.) in Nigeria to support this contract
- Provide a project-specific organogram showing the Names and Nationalities of all key personnel not limited to (Waste Management Supervisor, Waste Management Engineer, Waste Management Excavator Operator, Waste Management Forklift, Waste Management Support) that will execute the work scope for this service. CVs of all personnel listed in the project organogram should be submitted. For any position to be occupied by Expatriate personnel, tenderer shall commit to obtaining expatriate quota approval from NCDMB before project execution.
- Comply with the latest approved version of NCDMB HCD guidelines by committing (via a letter of undertaking) to providing Project-Specific
- Training, man-hour, budget, skill development, and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution
- Provide Valid Category 1,2,3,4 or 5 Non-Movable Assets (DA) group NCEC demonstrating ownership of Drill cuttings and waste management equipment to be utilized in the execution of the work scope.
- Ensure that all vessels (not limited to Barge, Tugboats) to be engaged in this project or service must be categorized as Nigerian owned in the NCDMB latest Marine vessel categorization or vessel owner must have Category A or B NCDMB Marine Vessel Certificate (NCMVC).
- Attempt to consider “briefcase” partners as a bypass means, to fulfil local content requirements will be rejected by the Board.

Please note that failure to provide any of the above documentation (or requirements) will be a fatal flaw.
