1.0 INTRODUCTION

Seplat West Limited, the operator of the NEPL/Seplat Joint Venture, hereby invites interested and prequalified companies with proven experience in the provision of Provision of Surface Well Testing services, including the supply of equipment, personnel, and associated services required for drilling, completion and workover operations within the Western Assets onshore wells for a contract period of three (3) years, with an option of an additional two (2) years at the Company's discretion.

2.0 SCOPE OF WORK

The scope of work includes the Provision of a Surface Well Testing, equipment, personnel and associated services. At a minimum, the contractor is expected to provide the following:

- Provision of Surface Testing Services and equipment
- Consumables spare parts; and
- Other related equipment and personnel

The contract is expected to run for three (3) years with an option to extend for an additional two (2) years, subject to performance and project requirements.

3.0 MANDATORY REQUIREMENTS

- To be eligible for this tender exercise, interested Companies are required to be pre-qualified in Product Code 1.01.02 - Surface Well Testing Services of NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified contractors in this category will receive an invitation to Tender (ITT).

- Demonstrate detailed description of the location of in-country committed facilities & infrastructure (address, layout drawing, lease document of technical & administrative office.) in Nigeria to support this contract.
- Provide a project-specific organogram showing the Names and Nationalities of all key personnel not limited to (Well Test Supervisor / Well Test Specialist, Well Test Engineer, Well Testing Operator, Assistant Pump Operator / Pumping Technician) that will execute the work scope for this service. CVs of all personnel listed in the project organogram should be submitted. For any position to be occupied by Expatriate personnel, tenderer shall commit to obtaining expatriate quota approval from NCDMB before project execution.
- Comply with the latest approved version of NCDMB HCD guidelines by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development, and understudy plan for Nigerian personnel utilizing OG TAN registered trainer(s) or other approved NCDMB training institution(s)
- Provide valid category 1,2,3,4 or 5 Services and Support (SS) or Construction & Movable Equipment (EC) group NCEC demonstrating ownership of Surface Well Testing Services Equipment for the execution of the work scope
- Ensure that all vessels (not limited to Barge, Tugboats) to be engaged in this project or service must be categorized as Nigerian owned in the NCDMB latest Marine vessel categorization or vessel owner must have Category A or B NCDMB Marine Vessel Certificate (NCMVC).
