2.0 SCOPE OF WORK

Scope of Services

The WORK to be covered under this CONTRACT generally consists of all works incidental and necessary to the successful completion of services related to the Provision of Engineering Design and Project Support Services and all other works within the scope of Works of Provision of Engineering Design and Project Support Services and shall include the following:
